Termination of the doctoral agreement and any third-party financed employment relationship associated with the doctoral relationship is possible at any time upon mutual agreement.

In the event of a negative assessment of academic performance before the end of the first year or in the event that the predicted success of the doctoral project is called into question, the doctoral agreement and doctoral relationship can be terminated at the end of this first year. If an employment relationship with the University of Basel is associated with the doctoral relationship, this will not be extended. In the event of a conflict, both parties can request mediation by the Doctoral Board.

Termination of the agreement and doctoral relationship will be mandated at the request of the Doctoral Committee or the doctoral student by the Dean of Research in consultation with the Faculty's Doctoral Board.
